Re: Oversight Hearing on FOIA at Federal Agencies

Dear Chairman Durbin,

The undersigned organizations write you to request the Judiciary Committee hold an oversight hearing on agency compliance with 5 U.S.C. § 552, the Freedom of Information Act (FOIA). The Judiciary Committee has a long history of working in a bipartisan manner to improve FOIA, and to provide vigilant oversight of agencies' compliance with the Act. Unfortunately, despite the importance of FOIA to ensuring transparency in government, the last oversight hearing on FOIA was more than three years ago. It is imperative that the Committee provide oversight of agencies' compliance with FOIA, both to understand FOIA implementation by the Trump administration, as well as to seek commitments to comply with the law from the newly confirmed Biden administration officials.

We strongly encourage the Committee to include testimony from voices outside government, in order to obtain the crucial perspective of members of the public who use FOIA often. It is vital that the Committee hear from those affected by months or even years-long delays at agencies. In addition, we recommend the Committee evaluate how agencies are implementing FOIA and explore the longstanding and worsening barriers to compliance. Topics which the Committee can explore include:

- The impact of COVID-19: Agencies struggle to administrate programs remotely, lack <u>access</u> to classified systems, or are burdened by a lack of electronic tools.<sup>1</sup>
- Increased litigation: The number of FOIA cases on the dockets have more than <u>doubled</u> in the last decade.<sup>2</sup>

- Over-redactions: The use of redactions, which are discretionary, <u>remains excessive</u> and often fails to comply with FOIA's presumption of openness.<sup>3</sup>
- Excessive delays: FOIA requests may languish for years or even decades within agencies, and delays are <u>worsening</u> as agencies' request volume continues to grow.<sup>4</sup>

We also urge the Committee to explore solutions to FOIA's pitfalls with recommendations from witnesses. Solutions include expanding proactive disclosures by agencies, reducing agency reliance on redactions, and strengthening judicial remedies. As the Judiciary Committee is preparing for an oversight hearing, we are available to assist in any way.
